PREQUALIFICATION REQUIREMENT

Interested and competent Companies wishing to carry out the above job must submit the following documents with the expression of interest: -

Mandatory (Without which companies will be disqualified)

- (i) Evidence of registration with Corporate Affairs Commission.
- (ii) Certified true copy of Memorandum and Article of Association.
- (iii) Evidence of payment of tax for the last three (3) years **as and when due** (such evidence should reflect the value of the projects undertaken by the Company in the last three (3) years).
- (iv) Certificate of Compliance issued by the National Pension Commission as evidence of fulfilling employer's obligation to employees with respect to pensions.
- (v) Evidence of payment of training contributions to ITF (Industrial Training Fund).
- (vi) **Proof of being manufacturer of the products;**
- (vii) **OR Proof of accreditation for the marketing of the medical equipment or importer/sole agent.**
- (viii) Current annual Certificate of Registration and retention of your premises used for your practice.
- (ix) Current annual license to practice as Pharmaceutical chemists, or Laboratory Scientist of the company.

Others

- (x) Comprehensive company profile.

- (xi) Evidence of previous business transaction with Government establishment
- (xii) Current Company's audited statement of accounts for the past 3 years, and duly stamped by a registered Auditor.
- (xiii) Company's registered address, functional contact email address,
- (xiv) GSM phone number(s) and facsimile number(s).
